## Air cargo - Unusual consignments

Have you noticed any of these indicators in the air cargo environment?

- Goods value vs freight charges
  - Does the value of the goods match the cost of airfreight charges?
- Is the client making repeated and persistent calls to clear the goods quickly?
- Has a client waited until the goods have cleared status and then provided an alternative delivery address, which does not fit the importer's profile?

If you have seen any of these indicators or similar patterns of behaviour, report it to Border Watch.

## 2017 Pre-border Seizures

In 2017 alone, Border Watch has received 28 referrals from industry members on seizures of prohibited imports destined for Australian addresses.

In excess of 65kgs of illegal goods were seized preborder, including;

- cocaine,
- heroin
- liquid methamphetamine, and
- opium.

## Engagement - AusPost Regional Expos

In June and July 2017, Border Watch Regional Coordinators attended the AusPost Expos in Sydney, Melbourne, Brisbane, Adelaide and Perth.

The purpose of the events was to educate AusPost managers and owners about Border Watch to.

The Border Watch booth and presentation received a great deal of interest, with discussion focusing on how offices can refer information relating to suspicious border activity.

## Case study – Tobacco

Border Watch received a referral from an industry member who reported a suspicious consignment. The consignee had previously come to notice for misdescribing the goods value. The member also had concerns that the description and size of the consignment did not match the importer's business.

On examination of the consignment, hundreds of kilos of tobacco were located with the attempted revenue evasion totalling more than two million dollars. This referral highlights the important role that industry members play in protecting the border.

Illicit tobacco trade is a criminal offence that denies the Commonwealth legitimate revenue and acts as a funding source for serious and organised crime.

#### Case study - Patience is a virtue

Not every Border Watch referral ends up in a positive result immediately. Often it can take months or years for an activity to occur.

A referral received in 2015, highlighting there would be a cross border movement of narcotics, finally came to fruition when two persons were intercepted at the border entry point. A search of both persons' baggage located a quantity of cocaine secreted into housewares.

It highlights that effective reporting can help protect our community, no matter how long the wait.

#### Case study - Methamphetamine

Information was received form a broker through Border Watch about a sea cargo consignment.

The industry member was suspicious about the shipment because of the following indicators:

- there was a request for the goods to a deliver to a self-storage unit
- the supplier was hesitant to supply an actual address and contact details
- false details provided for communication purposes.

This referral resulted in a large seizure of methamphetamine, located within the consignment, with a street value of over \$150 million dollars.
