

 About this snapshot

- The purpose of this report is to keep industry informed on the assessment and inspection progress of imported cargo as it moves through the cargo pathway.
- This symbol  in the report indicates initiatives that the Biosecurity Operations Division has implemented to improve regulatory efficiency and effectiveness.

Cargo Declarations

The volumes below relate to Full Import Declarations (FIDs) and Self Assessed Cargo (SAC) Import Documentation types that are lodged in the Integrated Cargo System (ICS). Declarations are then either:

- Referred to the Agriculture Import Management System (AIMS) or Import Management System (IMS) for assessment/inspection
- or
- Not referred as a result of profiling and screening activity.

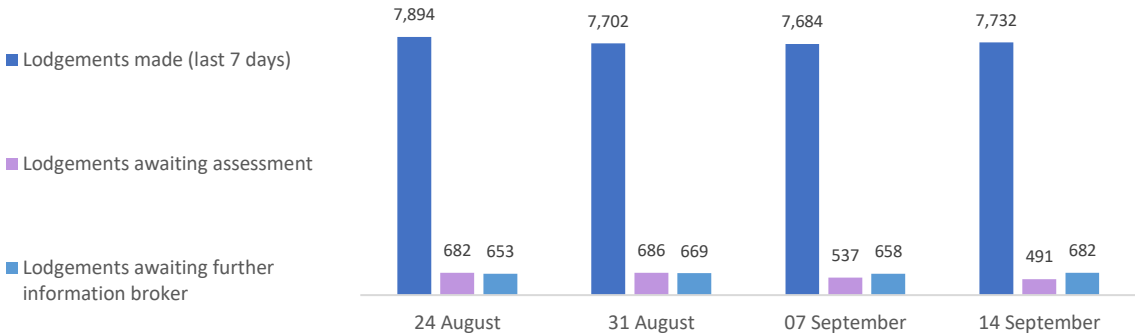

Post Biosecurity Detections

A Post Biosecurity Detection (PBD) occurs when a pest or disease risk is found in, or associated with, imported goods that are no longer at the intended biosecurity intervention point

The PBD function broadly aims to minimise the establishment of exotic pests and diseases through the management of biosecurity risk detected in imported goods beyond the biosecurity intervention point

i Data Definitions

Key Information: this reporting has been designed to provide a weekly ‘point in time snapshot’ of some imported cargo operations activities carried out by the department. The volumes provided in this report do not directly indicate the effort associated with managing biosecurity risk. Some data will vary from week to week in an active year due to amendments made to reported imported cargo.

Cargo Declarations

- **Declarations:** a count of Full Import Declarations (FIDs) and Self-Assessed Clearance (SAC) Import Documentation types that are lodged into the Integrated Cargo System (ICS).
- **Referred:** a count of import declarations that were referred to the Agriculture Import Management System (AIMS) or Import Management System (IMS) for intervention after profiling and screening activity.
- **Not referred:** a count of import declarations not referred as a result of profiling and screening activity.

Cargo Compliance

- **Documentation non-compliance rate:** the number of assessed lines that had a result indicating failure (non-compliance) as a percent of the total lines assessed.
- **Inspection non-compliance rate:** the number of inspected lines that had a result indicating failure (non-compliance) as a percent of the total lines inspected.

Assessments

- **Lodgements made (last 7 days):** a count of all lodgements into COLS in the previous 7 days. Lodgements can include assessments of FIDs, enquiries, reassessments and direction reissue requests.
- **Lodgements awaiting assessment:** a point in time snapshot of how many lodgements were in Cargo Workflow Management System (CWMS) awaiting an assessment. The number of lodgements awaiting assessment is not an indicator of lodgements that have exceeded service standard.
- **Lodgements awaiting further information from broker:** a point in time snapshot of how many lodgements were in CWMS that have been assessed as requiring further information or action from the broker.
- **Time in queue (business days):** a point in time snapshot of the count of lodgements on hand and the number of business days since lodgement was made. A business day is considered Monday to Friday and excludes national public holidays.

Inspections

- **Manned depot/recurring bookings:** a count of bulk inspections that take place at an approved arrangement during a specified appointment time or an entire day.
- **Food label visual inspection:** a count of directions associated with imported food products to ensure labelling meets import conditions. These inspections can take place in person or virtually.
- **Request for inspection lodged via the Biosecurity Portal (last 7 days):** a count of requests for inspections submitted by an authenticated person via the Biosecurity Portal in the previous 7 days.
- **Request for inspection awaiting scheduling:** a count of the requests for inspection submitted via the Biosecurity Portal or email and have not yet been scheduled to a biosecurity officer for inspection.
- **Inspections scheduled:** a count of inspection appointments that have been confirmed and scheduled to a biosecurity officer.
- **Time in queue (business days):** a point in time snapshot of the count of requests for inspection on hand and the number of business days since the request was made. A business day is considered Monday to Friday and excludes national public holidays.

Pest & Disease Detections

- **At border identifications:** a count of pest and disease organism identifications. Each identification may include multiple life stages and species. An identification may include live and/or dead specimens. Multiple pests or diseases may be identified during an inspection.
- **Post biosecurity detections:** a count of pest and disease organism identifications found in, or associated with, imported goods that are no longer at the intended biosecurity intervention point.
