Dear Valued Customer,

ANJ Container Services, wish to advise all of our valued customers and terminal facility users, that from Monday, the 6th November 2017, we shall be applying an Infrastructure levy on all FCL containers and FAK cargo, transitioning and presented for depot services through our Banksmeadow, terminal.

A necessary consideration for applying these levies to our clients and terminal users is due to the consequence of escalating costs impacting beyond the day to day operations of our 24-hour depot service, in the upkeep and infrastructure needs of a significant heavy user terminal and warehouse facility. These introduced levies support our increased cost in compliance, security, environmental and property maintenance all of which is required in sustaining a safe working environment in providing a premium service to our customers.

Levies are applied as follows:

- **FCL Container Infrastructure Levy** - Levied per Container either 20' or 40' at **\$22.50 per container**
That is all Containers that enter ANJ depot (excluding FAK containers for pack and unpack) will be subject to the FCL Container Infrastructure Levy
- **FAK Cargo Infrastructure Levy** - Levied per Cubic Meter of Freight at **\$ 9.50 per cbm**
FAK containers received into ANJ depot are not subjected to FCL Infrastructure Levies as a FAK Infrastructure levy applies to the freight component.

These levies are applied as standard rates and applicable to all of ANJ customers and terminal users being the account holders authorised to request ANJ to perform services on their behalf, levies will appear within the collective services invoice.
